- Monitor, review, and manage risks for participants, including those with complex needs;
- Lead or contribute to case conferences, ensuring clinical recommendations inform care decisions;
- Take on the role of clinical care partner for Restorative Care Pathway;
- Deliver pathway-specific nursing input across End-of-Life, and Assistive Technology & Home Modifications (AT-HM) pathways;
- Provide educate to participants and carers on health management;
- Maintain accurate clinical documentation and contribute to quality improvement and clinical governance activities.
